CIRCULAR

Subject: Declaration of Provisional Results of Research Review Meetings (RRMs) – Review by Subject Experts – Objections, if any – Reg.

In continuation of the Research Review Meetings (RRMs) conducted by the respective Departmental Research Committees (DRCs) during September 2025, it is hereby informed that the results as approved by the DRCs have been declared provisionally.

As a part of the quality assurance process, the subject experts appointed by the R&D Cell have independently scrutinized the DRC evaluation reports. Their review indicates certain variations and procedural shortfalls in a few departments with respect to uniformity in assessment and compliance with RRM guidelines.

In order to ensure fairness, transparency, and natural justice, the following procedure shall be adopted:

- 1). The PROVISIONAL RESULTS of the RRM are announced as per DRC recommendations.
- 2). Scholars who wish to seek clarification or raise objections, if any, against the DRC evaluation or observations therein, may submit a written representation to the Director, R&D Cell, through their respective Supervisors within seven (7) days from the date of publication of this circular and provisional results.
- 3). Only such cases where objections are received shall be reviewed in the light of the subject-expert observations.
- 4). In cases where the subject experts have identified academic or procedural shortfalls, the concerned scholar shall be notified and required to address the deficiencies by re-presenting the specific portions of work to the R&D Cell.
- 4). If no objection is received within the stipulated period, the DRC recommendations shall be deemed to be final and approved.
- 5). This measure is intended to uphold the academic integrity of the review process while avoiding undue delay in progression of research scholars.

Note: An annexure shall be attached along with results announcement to raise objections or to make representations on DRC results through proper channel to R&D Cell.
